The Chairperson, Deputy Luiz Piauhylino, from Brazil, welcomed the delegates. He observed that the purpose of the Preparatory Meeting was to determine the planning for the Third General Assembly of IPAIT: the meetings to be held topics for discussion, and the documents to be prepared.

He emphasized that, as the meeting of the Preparatory Committee was not included in the official sessions of the event, the resolutions taken during the meeting would have not an official nature, but would be submitted as recommendations and appreciated during the plenary sessions of the III IPAIT.

The Chairperson also explained that the Preparatory Committee was formed by the representatives of IPAIT member countries that shall take part in the III IPAIT. The Chairperson then proposed the following items for the agenda of the meeting:

- 1. Approval of the Agenda of the meeting of the Preparatory Committee for the III General Assembly of IPAIT

The plenary session approved the Agenda proposed.

2. Installation of the Steering Committee for the III IPAIT

The Chairperson clarified that, pursuant to Article 13 of IPAIT Charter, the General Assembly may install a Steering Committee and other committees, as required. Brazil, as a host country, proposed to install a



Steering Committee for the III IPAIT, which shall be in charge of coordinating the works and reviewing all formal documents to be adopted and approved by the General Assembly. The term of office of the Steering Committee shall begin from the day it is elected, at the First Plenary Session of this General Assembly of IPAIT, up to the day a new Committee is elected, at the next General Assembly, pursuant to Article 13, Chapter 4 (Committees), of the IPAIT Charter.

3. Approval of the Activity Program for the III IPAIT

The Chairperson proposed that the Activity Program for the III IPAIT consisted of the solemn opening session, three plenary sessions, three concurrent discussion panels, committee meetings and adjournment. During the plenary sessions, the reports of the member countries would be submitted. The proposal for the Activity Program was approved and shall be appreciated during the First Plenary Session.

4. Approval of the Agenda of the First Plenary Session for the III General Assembly of IPAIT

The Agenda for the First Plenary Session to be held on Monday, June 6, 2005, from 2:30 p.m. to 6:00 p.m., was submitted to appreciation with the following subjects:

Upon considerations, the Agenda was approved and shall be appreciated during the Third Plenary Session.

7. Approval for the installation of committees and discussion panels to the III IPAIT

The Chairperson clarified that the Article 13 of IPAIT Charter allows the General Assembly to install a Steering Committee and other Committees, as required. Brazil, as a host country for the III IPAIT,



proposes the installation of discussion panels and committees for the III IPAIT, as follows:

- 1. Discussion panel on "Instruments of Digital Inclusion";
- 2. Discussion panel on "Funding of Digital Inclusion";
- 3. Discussion panel on "Digital Inclusion: The role of the Public Authorities and of the Parliament for the Infoinclusion":
  - 4. Committee for Preparing the Joint Communiqué;
  - 5. Committee for Preparing the Brasilia Declaration.

Each panel and committee shall have a Chairperson and a Co-Chairperson who shall act as moderators, and shall be also in charge of reporting. Either Chairperson shall submit his report to the Third Plenary Session.

Upon resolutions, the proposal for creating discussion panels and committees was approved, and shall be appreciated during the First Plenary Session.

In addition to that, it was clarified that the attendance to any panels and committees shall be an option to all members of IPAIT, without a prior enrollment required.

It was resolved that the Brasilia Declaration and the Joint Communiqué shall be approved by the Steering Committee, and forwarded to appreciation by the General Assembly.

8. Approval of new member countries

The existence of 42 countries member of IPAIT was informed since the installation of IPAIT in Seoul, Republic of Korea, in 2002. They are: Albania, Angola, Saudi Arabia, Algeria, Australia, Bangladesh, Belgium, Brazil, Canada, Kazakhstan, China, Costa Rica, Croatia, El Salvador, Spain, Ethiopia, Philippines, Finland, Guatemala, Holland, Yemen, Fiji



Islands, India, Iran, Israel, Italy, Jordan, Lithuania, Malaysia, Morocco, Nepal, Niger, Poland, Kenya, Republic of Korea, Romania, Rwanda, Sudan, Thailand, Turkey, Venezuela, and Vietnam.

In this III IPAIT, the presence of 15 member countries represented by their parliamentary delegations was acknowledged (Angola, Saudi Arabia, Algeria, Belgium, Brazil, Republic of Korea, Spain, Finland, Iran, Italy, Jordan, Morocco, Romania, Sudan, and Thailand) and 2 member countries represented by their diplomatic corps (China and Guatemala).

For such a meeting, Brazil invited the parliaments of Latin America countries non-members of IPAIT for attending the III IPAIT, 2 countries of which are represented by parliamentarians - Honduras and Mexico - and 1 country is represented by its diplomatic corp - Uruguay.

As a manner for encouraging the increase of countries member of IPAIT, Brazil requested that, in accordance with Article 4, Chapter 2, of IPAIT Charter, Honduras, Mexico, and Uruguay are admitted to IPAIT, in the event they show to be interested to become members of the Association during this General Meeting. It was clarified that the new members shall have their condition made official upon approval by the III General Assembly of IPAIT, pursuant to Article 4, Chapter 2, of IPAIT Charter.

Upon resolutions, the proposal for admitting new members of IPAIT was approved, and shall be appreciated during the First Plenary Session.

9. Indications of Chairpersons and Co-chairpersons for discussion panels and committees for the III IPAIT

The appointment of Chairpersons and Co-Chairpersons for discussion panels and committees of the III IPAIT, approved by this Committee, was requested until Monday, June 6, 2005, before noon, with the Secretariat



of the III IPAIT, to be submitted to approval by the First Plenary Session of the III General Assembly of IPAIT.

10. Admission of observers for the III IPAIT

The Preparatory Committee approved the forwarding of the list of observers, pursuant to item 1, Article 5, Chapter 2, of IPAIT Charter, for approval during the First Plenary Session.

11. Admission of non-IPAIT member participants to the III IPAIT

Brazil asked for the approval of the following lists of attendants for the III IPAIT, who were not members of the Association. It was clarified that pursuant to the provisions in Article 5, of IPAIT Charter, the General Assembly shall approve its presence or participation at General Assemblies.

- 1. Representatives of Diplomatic Corps in Brazil, appointed by their national parliaments for representing them at the III IPAIT. They shall be granted the floor, voting rights, and the status of "participant";
- 2. Representatives of Diplomatic Corps in Brazil, present at the III IPAIT as part of the members of the delegation of their Parliament. They shall be qualified as councilors, without right to floor or vote.
- 3. Representatives of general Diplomatic Corps in Brazil, which are present at the III IPAIT. They shall be granted the status of Diplomatic Corp, and they may attend the General Assembly and discussion panels, without right to floor or vote.
- 4. Representatives of governmental agencies, universities, and private organizations in Brazil. They shall have the status of visitors to the III IPAIT, without right to floor or vote.

In order to enhance even more the debates of the III IPAIT, Brazil proposed that the following authorities could hold the floor during the



discussion panels of the III IPAIT, as key-note speakers, because of their noteworthy expertise in matters to be addressed during the panels. Such authorities shall be not granted the right to vote. They are: Mr. Rogério Santanna, Secretary of Logistics and Information Technology for the Federal Planning, Budget, and Management Department (Brazil); Mr. Mohamed Muhsin, Vice-President of the World Bank; Mr. Armando Mariante Carvalho, Director of the National Bank for Economic and Social Development ("BNDES") (Brazil); Deputy Eduardo Campos, Minister of Science and Technology (Brazil), and Ives Gandra da Silva Martins, Esq., tax expert (Brazil). The representative of Republic of Korea, Deputy Kim Hyu Seuk proposed that representatives of Thailand and Republic of Korea could take part as key-note speakers at the discussion panel "Digital Inclusion: The Role of the Government Authorities and Parliaments". He also requested the participation of the Minister of Communications of Brazil at the meeting. Deputy Kim Hyu Seuk was appointed as a key-note speaker for said panel. The Chairperson informed that he shall use efforts for the representatives of the Federal Communication Agency to attend the event.

Upon resolutions, the lists of non-member participants to the III IPAIT and key-note speakers were approved, and shall be appreciated during the First Plenary Session.

12. Proposal for the creation of the Executive Secretary to IPAIT

The suggestion submitted by the delegation of Thailand of installing a permanent or temporary Executive Secretary for IPAIT was discussed with the purpose of facilitating the organization of future Assemblies of the Association, and to assure the continuance and accompaniment of actions developed by the entity. It was considered that for the Secretariat



to be created, changes in IPAIT Charter shall be required, as well as the definition of fund sources for costing it.

After understandings, it was concluded that the Association is not mature enough for counting on a permanent secretariat. The importance of creating national sections, Chapter, of IPAIT was pointed out, in order to facilitate the interchange of information among the members of the Association in the period between General Assemblies.

13. Determination of host country and date as regards the IV General Assembly of IPAIT

The interest shown by Finland in being the seat of the IV IPAIT in the month of January, 2007, when the event would be part of the commemoration of the 100 years of Parliament in that country was discussed. Upon agreement by the plenary session, the candidature shall be taken to resolution during the First Plenary Session of the III General Assembly of IPAIT, as set forth by Article 7, Chapter 3, of IPAIT Charter.

14. Other matters

There were no pronouncements.

The meeting was adjourned at 6:00 p.m.






