Support to International Passengers on limitation of liability
Passengers embarking on a trip that implicates the final destination in a country other than the country of departure are warned that the provisions of a treaty known as Montreal Convention or its previous treaty, the Warsaw Convention, may be applied to their entire trip, including the part within the countries of departure and destination. Overbooking
